

**APPOINTMENT OF CHURCH TRUSTEES
LOUDOUN CIRCUIT COURT**

The Application or Petition must be accompanied by minutes of the meeting in which the trustees were elected. The minutes must be provided on Church letterhead and should include: new appointments, new retirees; and changes in organization. All required documents below must be completed fully.

REQUIRED DOCUMENTS:

- Cover Sheet
- Original Petition/Application
- Original Order
- Copy of minutes from the meeting electing trustees on Church letterhead, which should include: new appointments, new retirees and changes in the organization.

FILING FEE: \$31

The Filing fee must be paid by cash, certified check, money order or personal check (no starter checks will be accepted) made payable to Clerk of Circuit Court.

\$26 recording fee (for up to ten pages) payable after the order is entered.

This must be a separate check or money order, made payable to "Clerk of Circuit Court." Check must be submitted after the order is entered.

FILING MAY BE SUBMITTED IN PERSON OR BY MAIL:

Upon filing the petition for appointment of substitution of church trustees, the order will be submitted to the Judge's chambers for entry. No hearing is required for appointment/substitution of church trustees. If the Judge grants the petition to appoint/substitute church trustees, you will receive a certified copy of the final order if a self-addressed stamped envelope is provided.
