Civil Term Day – First Monday of every month

Civil Scheduling – every Monday and Tuesday at 9a.m.

Civil Motions Day – every 1st, 3rd and 4th Fridays. 9a.m. uncontested; 10a.m. contested non-domestic; 2p.m. contested domestic. On the Fridays that there is only an a.m. motions docket; domestic cases shall be set at 10a.m.

Criminal Term Day – Second Monday of every month; indictment returns Tuesday after Criminal Term Day at 2p.m.

Criminal Scheduling – on the indictment return docket at 2p.m.

Criminal Dockets Thursdays – 9a.m. misdemeanor appeals; 10a.m. pleas, sentencing, probation violations; 1p.m. motions, specially set matters
